

Rating Action: Moody's assigns Aa3 to Columbia County, NY GOs

New York, November 09, 2021 -- Moody's Investors Service has assigned a Aa3 rating to Columbia County, New York's \$9.3 million Public Improvement (Serial) Bonds, 2021. Additionally, Moody's affirms the county's Aa3 issuer rating and Aa3 outstanding general obligation limited tax (GOLT) ratings. The county currently has about \$50 million in debt outstanding.

RATINGS RATIONALE

The Aa3 rating reflects the continued increases in the county's financial position, driven by conservative budgeting practices and strong sales tax results despite the ongoing COVID-19 pandemic. Additionally, the rating reflects a strong regional economy, conservative financial management, and low fixed costs.

We consider the outstanding debt to be GOLT because of limitations under New York State law on property tax levy increases. The lack of distinction between the GOLT rating and the Issuer rating reflects the county's ability to override the property tax cap and the county's faith and credit pledge in support of debt service.

RATINGS OUTLOOK

Moody's does not usually assign outlooks to local government credits with this amount of debt outstanding.

FACTORS THAT COULD LEAD TO AN UPGRADE OF THE RATINGS

- Further strengthening in financial reserves
- Continued growth in property tax base

FACTORS THAT COULD LEAD TO A DOWNGRADE OF THE RATINGS

- Declines in fund or cash balance levels
- Substantial increases in debt or long term obligations

LEGAL SECURITY

The bonds are general obligations secured by the county's faith and credit backed by its commitment to levy ad valorem property taxes to pay debt service as limited by New York State's Property Tax Cap-Legislation (Chapter 97 (Part A) of the Laws of the State of New York, 2011).

USE OF PROCEEDS

Proceeds from the 2021 bonds will finance various road and bridge improvements throughout the county.

PROFILE

Columbia County is located in eastern New York State in the Hudson river valley about two hours north of New York City (Aa2 stable). The city of Hudson is located in the county and the county has a population of approximately 60,371. Major employers in the county include the Columbia Memorial Hospital, local governments, farms, nursing homes, and Wal-Mart.
